CALL FOR PAPERS

The Chair in Business Administration, Banking and Financial Management of the Institute for Finance at the University of Liechtenstein is pleased to announce a call for papers for a small and exclusive conference on sustainable finance, which will be held on 22 September 2022 at the University of Liechtenstein in Vaduz, Principality of Liechtenstein, this year the first time as a hybrid conference via Zoom and on Campus.

The aim of the workshop is to bridge a gap between academics and professionals on issues surrounding sustainable finance, with a primary focus on asset and investment management. As such we invite empirical and theoretical academic papers, which will be discussed both by an academic and a practitioner. Topics of special interest are, but not limited to:

- ESG related research (integration, materiality, risk relevance, etc.)
- Impact Investing, Sustainable Development Goals (SDGs)
- EU Taxonomy on Sustainable Finance, Regulatory issues (MiFID II, IDD, Benchmark Regulation, etc.)
- Corporate Sustainability Reporting
- Low carbon Portfolio Management, Green Bonds, Sustainable Loans
- Climate Finance, Renewable Energy Finance

Papers presented at the conference will be invited for submission to the **Palgrave Macmillan Series “Studies in impact finance”** and to the **Topical Collection “Sustainability in Financial Industry”** of the journal [Sustainability](#). Each accepted paper has to be presented on the workshop by one author, followed by a discussant from VP Bank AG, Vaduz/Liechtenstein as well as by one of the workshop speakers. Discussants will be assigned by the organizers in advance.
